**APPEAL No.08/2018-19 BEFORE
FIRST APPELLATE AUTHORITY UNDER
RIGHT TO INFORMATION ACT (RTI ACT), 2005**

Background:

The Appellant, Shri Felix, 347, 2/3 Main, I Block, Ramakrishna Nagar, Mysore, PIN: 570022 has preferred the present appeal dated August 07, 2018 under section 19(1) of RTI Act (received by office of First Appellate Authority (FAA) on August 07, 2018) against the Order No.2437 dated July 16, 2018 passed by CPIO requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his Appeal dated August 07, 2018, as also the order No.2437 dated July 16, 2018 passed by CPIO in the matter. It is observed that vide his RTI application dated July 14, 2018, the appellant had sought various information i.e. (1) Yearwise list of schemes and the scheme details announced both by the State Government and Central Government for the MSMEs from the year 2010 to 2018, (2) Yearwise details the different types or categories of MSMEs located at Mysore District (Talukwise) from the year 2010 to 2018 for the following: ; 2(a) List of MSMEs, established at Mysore District (Talukwise) from the year 2010 to 2018; 2(b) Amount of loans disbursed to MSMEs located at Mysore District (Talukwise) under the schemes announced both by the State Government and Central Government from the year 2010 to 2018; 2(c) Amount of loans disbursed by various financial bodies or institutions, announced both by the State Government and Central Government from the year 2010 to 2018; 2(d) Total investment made by the MSMEs located by Mysore District (Talukwise) from the year 2010 to 2018; (3) Yearwise and industry category

wise details of the total production of MSMEs located at Mysore District (Talukwise) from the year 2010 to 2018, list of MSMEs; (4) List of MSMEs in: 4(a) Agro Processing Sector located at Mysore District (Talukwise) from the year 2010 to 2018 and their Total Investment and Total Production, 4(b) Food Products Sector located at Mysore District (Talukwise) from the year 2010 to 2018 and their Total Investment and Total Production, 4(c) Agriculture and Allied Products Sector located at Mysore District (Talukwise) from the year 2010 to 2018 and their Total Investment and Total Production, 4(d) FMCGs Sector located at Mysore District (Talukwise) from the year 2010 to 2018 and their Total Investment and Total Production, 4(e) Industrial Products Sector located at Mysore District (Talukwise) from the year 2010 to 2018 and their Total Investment and Total Production and (5) The total amount disbursed by various financial institutions (Nationalised Banks & RRBs, Cooperative Banks, Industrial Banks, etc.) to MSMEs located at Mysore District (Talukwise) from the year 2010 to 2018.

Not satisfied with the reply given by the CPIO, the Appellant has made this appeal on the grounds that CPIO has provided incomplete, misleading or false information. Further, the Appellant mentioned that he had sought information in connection with two reports of SIDBI i.e. 1) SIDBI Report on Micro, Small and Medium Enterprises Sector 2011(www.sidbi.in/files/SIDBI-Report-on-MSME-sector-2011.pdf) and 2) MSME database 2010 (www.sidbi.in/files/MSME-Database-2010.pdf) and CPIO vide letter dated 16/07/2018 mentioned that SIDBI does not maintain such data/information.

On going through the appeal, application, CPIO's order and other relevant records, I find that the CPIO could not furnish the information sought by the appellant as the same was not available with the Public Authority (SIDBI). The obligation of CPIO to furnish the information arises in case the information is available with the Public Authority and the same is not exempted from the disclosure under the provisions of RTI Act.

Since the information is not available with the Public Authority (SIDBI), I do not find any infirmity in the order of the CPIO and the same is upheld.

Order:

The appeal is accordingly disposed of.
