The Appellant Shri Pramod Goel, resident of 98-Hope Apartments, Sector -15, Part-2, Gurgaon-122001, has preferred the present appeal dated June 03, 2017, received on June 13, 2017, against the order No.2111 dated May 04, 2017 by CPIO of Small Industries Development Bank of India (SIDBI) in response to his application dated April 05, 2017, seeking information/queries with regard to account of K.K. Organics Pvt. Ltd.

The Appellant has challenged the said order dated May 04, 2017 of CPIO inter alia, on various grounds alleging that the information provided is not specific, vague and incomplete.

I have gone through the contents of the Appeal dated June 03, 2017, the application dated April 05, 2017 of the appellant as also the order No.2111 dated May 04, 2017 passed by CPIO in the matter. It is observed that the appellant has sought information on wide issues regarding the account of K.K. Organics Pvt. Ltd with SIDBI, of which he was promoter director.
