APPEAL NO. A-05/2020-21 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Adv Pavitra H Arora, 354-B 30 Civil Lines, Roorkee, Pin:247667, Uttarakhand, has preferred the present appeal dated May 23, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on May 23, 2020 against the letter number 197978 / RTI-5 /2884 dated May 20, 2020 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated May 23, 2020 as also the letter number 197978 / RTI-5 /2884 dated May 20, 2020 passed by CPIO in the matter. It is observed that vide his RTI application dated May 11, 2020, the appellant has sought information on 1) This refers to a customer of yours from Haridwar District called Jaisanshu Medicare Private Limited. The customer had approached my client M/s Hemant Arora & Co LLP which made his Project Report, CA Certificates and approached SIBBI for Loan in the Month of September 2018, his loan was sanctioned in August 2019. I wanted to know the details of the CA Certificates submitted and the CMA data used is from this firm or not. Kindly confirm.

Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that refused access to information requested.

I have perused the orders of CPIO and observed that the applicant has requested for two sets of information viz. details of CA certificates submitted and the
